



## VKDCNY Guidelines and Agreement

Dear Parents and Students,

It is our pleasure to welcome you to Valentina Kozlova's Dance Conservatory of New York. In order to ensure that every participant is safe and comfortable and has a pleasant experience, please review VKDCNY's rules, regulations and guidelines. Please check each box and return this signed form in order to participate in the program.

1. Every student must present a letter or certificate of **medical examination** and good health. This required for your child's wellbeing and to inform us that she/he is able to participate fully in the program. This certificate should inform VKDCNY of any injuries, health ailments and /or allergies and the proper accommodation for such concerns. Please be aware that VKDCNY is not responsible for any injuries or health concerns/ailments during the program.

2. All students are required to wear appropriate uniform attire and maintain a neat appearance. The uniform is as follows:
  - Girls: **School leotard, pink tights, pink technique slippers**, hair in a neat bun secured with a hairnet. Pointe shoes for those on pointe. Please bring extra tights and leotard if necessary and all accessories needed.
  - Boys: **White t-shirt, black tights, white technique slippers**. Please bring an extra t-shirt and tights.

3. Tuition and Tuition Deposits must be paid when they are due. Payments made after the due date, may be assessed a late fee. **Tuition is non-refundable.**

4. Students are to arrive to classes on time and attend all scheduled classes unless they have been excused by Valentina Kozlova or have a doctor's note. **Only 5 excused absences are permitted.** If absences exceed 5, parents and dancers understand that he/she may be asked to observe class(s) and performance opportunities may be affected. Students in Levels 3 and higher are required to get ALL absences initialed by Ms. Kozlova upon their return to class. The student may be asked to observe class rather than participate if absences have not been approved upon their return.

5. All students are expected to conduct themselves in a well-mannered fashion and display appropriate behavior. Talking during class is not permitted.

6. There is no food or drinks allowed in the studios along with the dressing room areas – water only please. When you bring food into the reception area, they must be sealed and when you are done eating, all food must be thrown away in the bathroom trashcan because of the undesired smell

7. Parents are not allowed beyond the reception area unless otherwise instructed by Ms. Kozlova or the front desk. Observation classes are scheduled during the year.

8. VKDCNY targets pre-professional dancers and offers several performances that are not a recital but a Gala. Every performance that you do requires a payment for rehearsal time. This fee also covers the production cost of the performance. There will be performances entitled, “In Studio Performance”, these performances will have free admission and there will be no Performance Fee.

9. Performance rehearsals will take place on the weekends and occasionally on the weekdays. The closer it comes to the performances; the more rehearsals will be scheduled with the possibility of Sunday. Students must attend all rehearsals. If excused absences exceed two, parents and dancers understand that the child may be asked NOT to participate in the performance.
